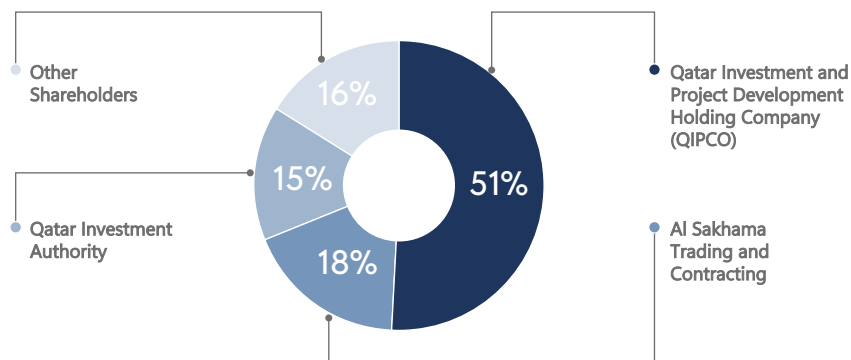

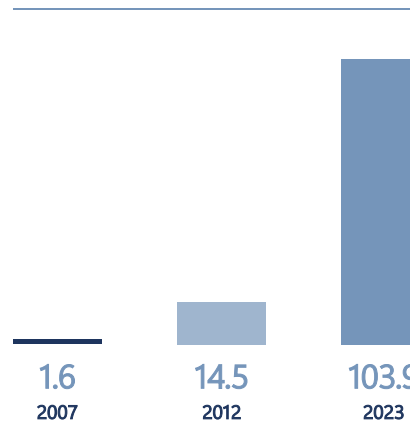

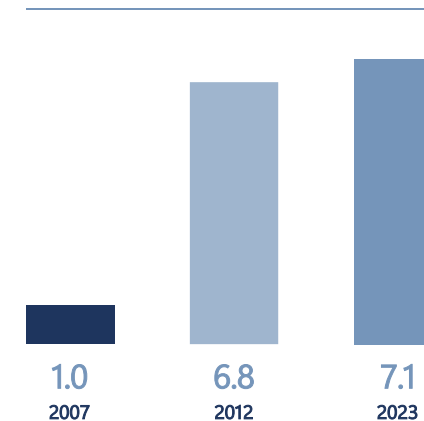
Total Revenue

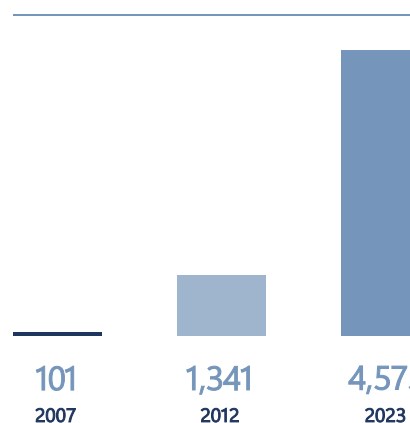
Total Assets

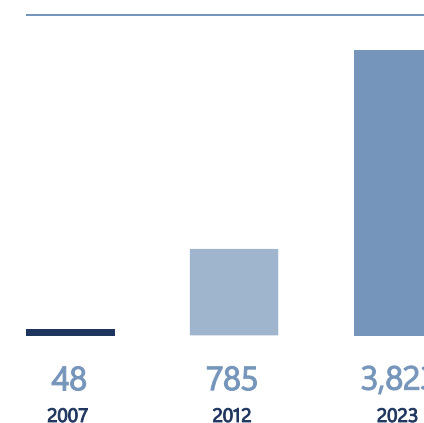
Total Net Profit

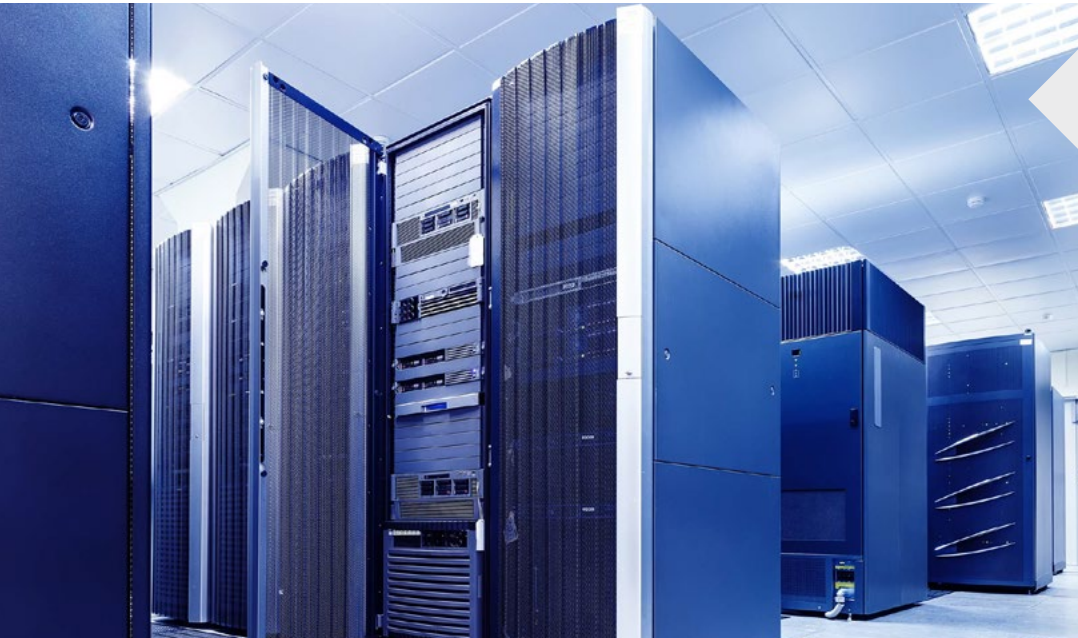


Total Cash Dividends

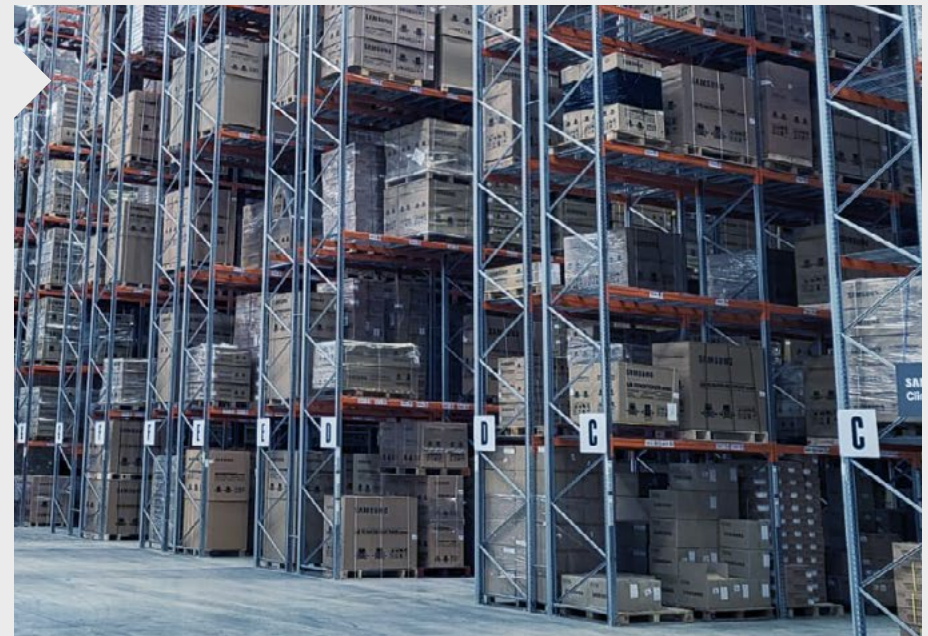
